# "PERU: A COUNTRY OF MINING OPPORTUNITIES"

The COVID-19 pandemic set the world's agenda in 2020. Peru was no different; the pandemic hit Peru hard. Its economy shrunk by approximately 12% and its health care system has been challenged as never before. Strict quarantine measures were put in place. However, the country's resilience has once again been evidenced. Employment levels are now rising and will shortly reach pre-pandemic levels. Mining production has also increased and there is confidence that pre-pandemic levels will be reached and surpassed. There is also optimism that the upcoming general elections of April 2021, will contribute to ease the political turmoil experienced in 2020. This, in turn, should catalyze the recovery of the Peruvian economy, which is expected to grow by two digits in 2021. Peru is and will continue being a mining country. Peruvian mining and its portfolio of 46 projects with an expected US\$ 56.1 billion aggregate investment, should be one of the main engines of that recovery.
